



Tipsters Terms & Conditions

1. Eligibility & Registration

- Open to individuals aged 18+ only.
- Must register via the official portal/link/website to participate.
- One account per person; duplicate accounts will be disqualified.

2. Assessment

The first week after one registers and creates an account to supply tips will be considered as probation or assessment week. During this week the tipsters will be required to send their tips at any time of the day for seven days.

Tips must be submitted in the prescribed format i.e either typing in or uploading a clear photo of your selections.

Tips must be submitted at least one hour before the start of the matches listed on the multi-bet slip.

Contract to supply betting tips shall be awarded to tipsters who submitted winning tips for at least the minimum required correct days as per the table below;

<i>Odds package</i>	<i>Requirements during trial week (first week)</i>
<i>5 Odds</i>	<i>To qualify for the contract you need to have submitted correct tips in at least 4 out of 7 days of the first week</i>
<i>10 Odds</i>	<i>To qualify for the contract you need to have submitted correct tips in at least 3 out of 7 days of the first week</i>



15 Odds	<i>To qualify for the contract you need to have submitted correct tips in at least 3 out of 7 days of the first week</i>
20 Odds	<i>To qualify for the contract you need to have submitted correct tips in at least 3 out of 7 days of the first week</i>
25 Odds	<i>To qualify for the contract you need to have submitted correct tips in at least 3 out of 7 days of the first week</i>

3. Contract

Once the tipster passes his/her assessment they will start supplying their tips on contract and get paid daily.

During the contract, the tipster can submit tips daily or on specific days as they may wish as long as they meet the minimum required win days per week.

The contract shall be automatically renewed on a weekly basis subject to meeting the minimum win days per week as per the table below. Those who do not meet the minimum win days shall have their contracts terminated.

Odds package	Requirements during contract
5 Odds	<i>During the contract you will be required to submit correct tips in at least 3 out of 7 days per week for four weeks</i>
10 Odds	<i>During the contract you will be required to submit correct tips in at least 2 out of 7 days per week for four weeks</i>
15 Odds	<i>During the contract you will be required to submit correct tips in at least 2 out of 7 days per week for four weeks</i>



20 Odds	<i>During the contract you will be required to submit correct tips in at least 2 out of 7 days per week for four weeks</i>
25 Odds	<i>During the contract you will be required to submit correct tips in at least 2 out of 7 days per week for four weeks</i>

Payments during the contract will be made weekly and will be calculated as daily rate times the number of days you submitted correct tips within the week.

*Please note that tips must be submitted at least **1 hour** before the start of the earliest match on your tips list.*

Tips must be submitted once a day.

Subscribers Terms & Conditions

1. Eligibility & Registration

- Open to individuals aged 18+ only.
- Must register via the official portal/link/website to participate.

2. Subscription Rules

Subscribers that buy our tips shall be bound by the following terms and conditions;

Subscriptions shall be made on a weekly basis.

A proportional subscriptions refund shall be made to subscribers in the case that they fail to get the minimum guaranteed win days.

Tips shall be sent strictly through the subscribers registered email address.

Subscribers are advised to constantly check their email addresses as tips are sent any time of the day.

The matches on the bet slip shall comply with “at least one hour” match start time rule to give the subscriber enough time to use the tips.

Privacy Policy
